## Welcome

- Angie introduced herself and welcomed everybody to the meeting, she then introduced Camilla.
- Camila talking about Raul being the Spanish translator for the meeting
- Prisoners were reminded to speak slowly to allow for adequate time for translators to do their job
- Angie introduced the Board of Education representatives Jennifer and Tanesha to address the DAC

### **Presentations**

### Jennifer Woolfsie and Tanesha Ford (Board of Education Directors)

- Jennifer spoke about the relationship between the Board of Education and District Advisory Committee (DAC)- DAC is to advise the BOE and to represent each school with DAC Delegates identified by each school's parent org
- The school district is currently looking at changing high school and middle school start times for the upcoming school year with the start time being set at 8:20 AM for MS and HS, but elementary schools will stay at their original 9:15 AM start time
- Attendee question- What the rational was for making this time change?
  - Jennifer indicated that studies showed that the older students performance improved with a later start time across the country
- Tanesha requested everyone to be an active participant in the development of the new Blueprint 2030 Strategic Plan
- Attendee question- Are there plans to change the district administrative policies KCA and KDAA, which have not been updated since about 2010? The language in those policies is outdated and refers to the school SACs and the DAC but it's not Include other parent orgs such as PTAs, PTOs, or other forms of parent orgs.
  - Jennifer indicated she was aware of those policies and that the board recognized all those forms of parent organizations. She suggested that DAC bring this up with administration and that the BOE would also look at the issue.
- Attendee question- Has the school district looked at how the change in start times would effect after school activities and particularly athletics?
  - Jennifer noted that has been looked at, but we need to follow up on that process to assure it is being adequately addressed, also how that might affect students that work after school
